Ordination Criteria for the Ministry of the Gospel

- 1. Have a definite sense of God's call or leading into the ministry.
- 2. Be Biblically qualified as a minister according to I Timothy 3: 1-7

 This saying is trustworthy: "If anyone aspires to be an overseer, he desires a noble work."
- ² An overseer, therefore, must be above reproach, the husband of one wife, self-controlled, sensible, respectable, hospitable, an able teacher,
- ³ not addicted to wine, not a bully but gentle, not quarrelsome, not greedy—
- ⁴ one who manages his own household competently, having his children under control with all dignity.
- ⁵ (If anyone does not know how to manage his own household, how will he take care of God's church?)
- ⁶ He must not be a new convert, or he might become conceited and fall into the condemnation of the Devil.
- ⁷ Furthermore, he must have a good reputation among outsiders, so that he does not fall into disgrace and the Devil's trap.

Titus 1: 4-9.

- ⁴ To Titus, my true child in our common faith. Grace and peace from God the Father and Christ Jesus our Savior.
- ⁵ The reason I left you in Crete was to set right what was left undone and, as I directed you, to appoint elders in every town:
- 6 someone who is blameless, the husband of one wife, having faithful children not accused of wildness or rebellion.
- ⁷ For an overseer, as God's manager, must be blameless, not arrogant, not quick tempered, not addicted to wine, not a bully, not greedy for money,
- ⁸ but hospitable, loving what is good, sensible, righteous, holy, self-controlled,
- holding to the faithful message as taught, so that he will be able both to encourage with sound teaching and to refute those who contradict it.
- 3. Hold to sound evangelical, conservative doctrine.
- 4. Has received, or is now receiving Biblical and/or ministry training.
- 5. Has demonstrated commitment to their current ministry involvement.
- 6, Is now, or expects to be engage in a ministry position which includes some or all of the following: preaching, teaching, shepherding, counseling, leading and directing the affairs of a church, conducting weddings and funerals, administering Communion and Baptism, and leading in worship services.
